Notes / Terms

**Client agrees to not discuss the details of any estimate or scope of work with outside parties. The client also agrees to not approach any AGL employees or subcontractors to offer side jobs at any time.

** Any complaints that AGL and the client can not solve will be handled by an independent arbitrator or other means.

**Payment is due at time of completion. A deposit will be required on the first day of work. If there is an issue with the client's ability to pay in full please discuss it with AGL. There will be a \$50 late fee if payment is not received on time. Every 30 days there will be an additional \$50 late fee until paid in full or 90 days. If it is 90 days or greater, AGL has the right to secure a lien on the property, for non-owners AGL will send to collections or civil court.

** A deposit of 60% will be required prior to or at the start of the job. 40% of the balance at the time of completion or 50% to schedule and start, 25% at the halfway point, and 25% at completion. On long projects, terms and payment will be discussed,
